

# International Fee Notice 2021

---



All applications are prioritised based on the date of receipt of the application.

## Student Types

For the purposes of this Business Notice the following student types are referred to:

- PR – Permanent Resident Visa Holders
- TR – Temporary Resident Visa Holders
- FFPOS- Full Fee Paying Overseas Students
- International – FFPOS, PR & TR Visa Holders
- Domestic – Australian Citizens

## Application Fee

A \$350 fee is payable with an application for enrolment. This fee is neither refundable nor transferable. It provides for the administration of the application and entrance assessment.

## Security Deposit

A security deposit is required per the following schedule. It will be refunded once the last sibling/boarder student has departed the school.

Student Type	Deposit
Day Students per Family	\$1,600
Boarders per Student	\$3,500

The Security Deposit will not be refunded if there are fees outstanding (including library and other sundry charges) or if the child(ren) depart contrary to the **TKIS Fees and Levies Policy**.

## Confirmation of Enrolment

An offer of enrolment will not be confirmed until both the Security Deposit and the completed Enrolment Form and associated paperwork are received.

## ANNUAL FEES

School Fees at the Kilmore International School (TKIS) comprise the following:

- Tuition Fee;
- Consolidated Charge; and
- Capital Levy

### Tuition Fee

The Tuition Fee is the charge for providing the education for your child(ren).

### Consolidated Charge

The Consolidated Charge covers the cost of all compulsory excursions and camps, after school tutorials fee, library resources including the use of textbooks, a stationery pack, the school diary and Yearbook, musical instruments in Years 3-7, fees for participation in the International Baccalaureate (Year 12), administration fees and calculators. There is GST applied on some of these components.

## Capital Levy

All students are charged an annual levy to assist in our capital works program.

## DISCOUNTS

### Sibling Discounts

A sibling discount applies to the Tuition Fee only for second and subsequent siblings. The discount is 10% and it is automatically applied to your account.

### Residential Fees

The School has boarding available for students. Fees for boarding are in addition to the Annual Fees and include all meals, a laundry service and a student photo pack. Boarders at primary school age will only be considered in exceptional circumstances.

The School operates on two Semesters and the boarding fee covers the whole Semester except for:

- Years 7-10  
One week in the 1st mid-Semester break and two weeks in the 2nd mid-Semester break.
- Years 11-12  
One week in the 1st mid-Semester break and one week in the 2nd mid-Semester break.

Students may opt to remain in boarding during these breaks by payment of a Holiday Boarding Fee  
The boarding house is orientated toward secondary students.

### Holiday Boarding Fee

The break in Semester 1 consists of one week. The fee to remain in boarding for this week is \$610.

The break in Semester 2 consists of two weeks for students in Years 7-10. The fee to remain in boarding is \$1,210.

The break in Semester 2 consists of one week for students in Years 11-12, one week being the compulsory CAS Camp / Mock Exams (included in the Consolidated Charge). The fee to remain in boarding for the second week is \$610.

There is GST on some of this fee.

### **Residential Security Deposit**

A security deposit of \$3,500 is required from each boarding student. This will be refunded after the departure of the student, subject to our withdrawal policy.

### **Residential Entry Fee**

Boarding students will incur an initial fee on acceptance into boarding to cover the expense of administration, linen, desk lamps and power boards as well as the initial airport transfer and a uniform. This fee is \$1950.

### **Health Cover (on entry)**

The Australian Government requires that all Full Fee Paying Overseas Students (FFPOS) holding student visas must have Overseas Student Health Cover (OSHC) for the entire period of their student visa and stay in Australia. Please refer to the Department of Home Affairs website [www.homeaffairs.gov.au](http://www.homeaffairs.gov.au) for all relevant information. The School will charge an estimate for OSHC on the initial invoice. An adjustment will be made to your account once the cover has been accepted by Medibank Private. The fee will range from approximately \$4,000 for Year 7 students to \$1,200 for Year 11. This is a once-only charge.

### **Ambulance Cover**

All FFPOS students are also required to have ambulance cover. This is included in the Residential Fee.

### **Additional Charges**

Fees for extra-curricular activities such as music tutoring, non-compulsory camps and study tours will be billed as the charge is incurred. This includes airport transfers that are outside of the TKIS standard transfers.

### **Notice of Withdrawal**

One semester's notice in writing to the Principal is required advising the withdrawal of a student from the School, otherwise a charge equivalent to one term's fees will apply.

### **Absences**

No discounts or concessions will be granted for any absences unless pre-arranged with the Principal.

### **Uniform**

All students are required to adhere to the School's Uniform Code. The cost of the uniform is included in the Residential Entry Fee for boarding students. For day students the cost of a uniform is additional to the fees and charges listed in this notice. The School operates a Uniform Shop.

## PAYMENT METHODS

The payment of annual fees is by semester (two payments per annum). The first instalment is due and payable by January 15th. The second instalment is due and payable by July 15th. A penalty of \$250 will apply if these are not paid by the due date. Permanent Residents who have commenced the process of applying for Australian citizenship may apply to the Principal to adopt Domestic Payment Methods.

### Payment Options

Fees and charges may be paid by:

- Direct Deposit
- Credit card – MasterCard and Visa (surcharge fees apply)

### Temporary and Permanent Resident Rebate

The Australian Government provides some funding to the School for students who hold Temporary or Permanent Residence status. Students who are included in the annual government school census will be entitled to receive a rebate in September. This rebate is applied directly to fee accounts.

### Non-payment of School Fees

It is a CRICOS requirement the Full Fee Paying Overseas Students (FFPOS) do not have fees in arrears at the School. The School reserves the right to suspend or terminate enrolment of a student whose fees remain unpaid outside of the School's terms of payment. Access to optional and non-compulsory activities may not be available to students whose fees are in arrears.
